 - Either: Include an additional \$2500 to their stated bid to have the seller decommission the private sewage disposal system so that the time of transfer inspection and upgrading of the private sewage disposal system serving the property will not be required.
 - Decommissioning includes severing and capping the exterior sewer line and properly abandoning the private sewage disposal system.
 - If the buyer desires to utilize the plumbing in the structure, they will be responsible for ensuring that adequate treatment of the wastewater is provided.

OR

- Enter into a binding agreement with the Benton County Board of Health that the time of transfer inspection and upgrading of the private sewage disposal system serving the property will not be required as long as the structure is not occupied and is demolished by June 1, 2025.
 - Once the structure is demolished, the private sewage disposal system shall be properly abandoned which includes pumping the septic tank, crushing in the tank lid, and filling the tank with sand or soil.
 - Documentation of the abandonment shall be provided to Benton County Environmental Health.
- With exception of the septic clause, the property is purchased as is.
- Benton County Conservation must have the payment within two weeks of accepted bid.
- Once the bid is accepted on January 13th, bidder will be contacted by January 14th, a check must be made out to Benton County Conservation and in the department's possession by January 28th, 2025 at 10:00am.
