Consent Agenda (previous minutes, expenditures, revenues): Motion to approve by Scheel, seconded by Van Wey. All aye, motion passed.

## Old business

- a. City of Atkins Atkins Roundhouse Area: Williams shared email from City of Atkins request to remove brush pile. Conservation doesn't have a FEMA account for debris pile.
- b. **Hannen Lake Shop:** Supervisor meeting tomorrow on 10/11/22 for budget hearing. Budget will reflect funding for capital improvements after supervisor approval.
- c. Wildcat Recreation Development: The shop addition is completed; some bills will still be rolling in for electrical and heating and cooling, Wi-Fi options were discussed. Discussion on potential purchase, adjoining land and how many acres are needed around the Ranger residence and a potential high-water access for house and park. Williams will be following up with appropriate parties to further discussions.
