# **Benton County Conservation Board Meeting**

Guests or public participation: Marlys Harms and Jay Hermann, members of the Shellsburg Area Community Group, spoke about creating an MOU with BCCB and the Shellsburg School to help with managing the prairie located behind the school. The naturalists use the prairie for programming and staff have performed prairie burns. Harms and Hermann will start the process with the school to form an MOU.

Dale Henry with the VFW post 8884 asked about the ice fishing tournament. Grubic said the tournament will be at Rodgers Lake this year.

Consent Agenda (previous minutes, expenditures, revenues): Motion approved by LaGrange seconded by Scheel. All aye, motion passed.

- a. Wildcat Disc Golf Volunteers- MOU Update: Kelly Williams and Brad Routier, Wildcat Disc Golf Course volunteers, signed the MOU and gave an update on how the year went. This is the 15<sup>th</sup> year for the course. They gave a big thank you to Hagen and the rest of the staff for all of the hard work and cooperation. They raised more than \$2,000 in donations and saw more than 3200 people using the course through just one app for game scoring. This usage number does not count the people who do not use the app or multiple people using one scorer. LaGrange and Hill requested the group try and give Hagen quarterly numbers of users, this helps justify the importance of the parks.
