  - a. Bid Packets: Notice to Bidders will be posted publicly. Reiter discussed the alternate options that are posted within the bid packet in regards to heating. Estimated timeline shows bids going out in January 2023 and construction being completed in December 2023. Plan Bid Set: Contains detailed maps, drawings, and pictures for the shop.
