 - i. Funding/Outreach Currently have \$725,000 committed. Met with donors of \$250,000 last week and have secured \$100,000 to do a 1-1 match. Will be posted on social media this week. Donor agreed to be a point of contact for the Rockwell grant.
 - ii. Development Wells self-assessment has been submitted to IDNR engineer.

 - ii. Iowa Flood Center Hydrostation Will be out to flag locations in early March.
