Presentation on HACAP's Health Programs. Organization is the Contractor for WIC & 1st Five, and the Subcontractor for Title V MCAH services, and has strong partnership with Local Boards of Health. The Family and Community Health Alliance has 9 Health programs: WIC, Breastfeeding Peer Counselor, 1st Five, Maternal Health, Child & Adolescent Health, i-Smile, i-Smile @ School, Hawki & Childcare Nurse Consultant. HACAP is the Grant Holder for Linn, Benton, Johnes, Iowa & Johnson counties. IN FY 23, there were 9,002 unduplicated clients in all 5 counties

Environmental Health Report:

Shared the Summary of Activities for FY24 Q4, including well activity, well water sampling, grants to counties, private sewage disposal and animal bites. 28E Agreement with Linn County PH is still pending, Time of Transfers are picking up, well reconstruction is low due to homeowner investment cost, and animal bite numbers are remaining steady.

Currently, the department is busy with the Opioid Taskforce Settlement, the Vaccines for Children Program, and preparing for PH WINS. The department also was helped by VGH staff and Benton County EMA to secure remaining public health equipment that was in storage with VGH.
