Auditor Rippel would like to leave some cushion in case things come in over the quotes, granted some may come in lower too. Or if need be, there is spending authority under the capital projects fund too for some of the improvements or repairs to the facilities.

The time of 9:30 a.m. having arrived and publicized for the FY 25 Budget Amendment Hearing. Vice-Chairman Bierschenk opened it up for public comments. Auditor Rippel explained the various needs in the amendment and how some are pass throughs for grants to offset the new expenses, while others are just allowing more spending authority for the remainder of the ARPA funds and the new Opioid fund. We needed proper spending authority to loan Fremont Township temporary funds. The public health department needed some adjustments in service areas along with the Land Use Department for well testing grants. The weed department had insurance money to replace the skid loader, and other needs were juvenile detention and outside legal fees for the supervisors and attorney's budget. There was no public comments heard before or during the hearing.

**Seeman moved/Primmer seconded:** To adopt Resolution #24-99, Entering into a loan agreement between Benton County and Fremont Township . Primmer, Seeman and Bierschenk all voting aye. Motion carried.

RESOLUTION #24-99

WHEREAS, the Board of Supervisors of Benton County, Iowa was asked to enter into a Loan Agreement (the "Loan Agreement") and to Ioan money thereunder in a principal amount not to exceed \$350,000 for Fremont Township to repair their facility under FEMA standards;

WHEREAS, a certain Loan Agreement has been prepared to set forth the terms of the Loan Agreement and the understanding between the County and Fremont Township Officials; and

WHEREAS, it is now necessary to make final provision for the approval of the Loan and authorize the issuance of the funds as appropriate;

NOW, THEREFORE, Be It Resolved by the Board of Supervisors of Benton County, Iowa, entered as follows:

## BENTON COUNTY AND FREMONT TOWNSHIP

This agreement entered into on this date, is between Benton County and the Benton County Fremont Township, a legal entity. The specified purpose of this agreement is to provide a loan to the Township so that they can make necessary repairs to their township hall, which was severely damaged in a recent derecho. The parties further understand and agree to the following:

- 1. The Fremont township hall suffered extensive damage from the derecho with an estimated repair cost of \$450,000.00.
- The Township, through its clerk and trustees, has applied for Federal Emergency Management (FEMA) funding to repair the building.
- 3. The FEMA has approved funding to make the necessary repairs and improvements. They have obligated \$450,000.00 that is evidenced by documentation provided to Benton County, which is attached to this agreement.
- 4. The terms of the obligated funding require that the repairs be made prior to the disbursement of the funds.
- 5. The Township has received initial funding of almost \$100,000.00 and has a remaining shortfall of \$350,000.00.
- 6. Based on these facts, Benton County agrees to lend to the Fremont township the sum of \$350,000.00 for a period of one year. It is anticipated that the repairs will be completed by March 31, 2025 with funding from FEMA to follow.
- 7. In the event the FEMA, for some unforeseen reason, fails to provide funding as agreed, Benton County shall have the option to demand the Township repay Benton County the sum in its entirety over a period of ten years. If Benton County exercises said option, the Township shall levy pursuant to Iowa Code Section 360.8 and make yearly installments on the 1st day of October each and every year for ten years until the balance is paid.
- 8. Accordingly, the parties do hereby agree that Benton County will loan to the Fremont Township the sum of \$350,000.00 to be paid back with FEMA funding by October 1, 2025. All payments shall be paid to the Benton County Auditor.
- 9. This Agreement shall become effective upon all parties hereto signing, and shall be effective through October 1, 2025.
- 10. If any terms or provisions of this Agreement shall be held to be invalid or unenforceable for any reason, then the remaining terms and provisions shall continue to remain in full force and effect. If a court finds that any term or provision of this Agreement is invalid or unenforceable, but that such term or provision could be limited and thereby be considered valid and enforceable, then such term or provision shall be deemed to be written, construed, and enforced in accordance with said limitation.
- 11. This Agreement is the complete agreement between the parties. Any amendment to this Agreement must be made in writing and must be approved by the Benton County Board of Supervisors and the Fremont Township through its clerk and trustees.
